

**Hoodrich Films LLC  
Prepaid Management  
Agreement**

This letter will set forth our agreement as follows:

1. ENGAGEMENT AND TERM:

(a) I, \_\_\_\_\_ P/K/A \_\_\_\_\_ ("Artist") desire to obtain your advice, counsel and direction in the development and enhancement of my professional career. In view of the foregoing, I hereby engage you as my non-exclusive manager in music, for the term of \_\_\_\_\_ (\_\_) year ("Initial Period") commencing as of the date herein above under the terms and conditions hereinafter set forth.

2. SERVICES: You accept to provide management services for me under the following guidelines:

(a) To advise and counsel me with respect to decisions concerning employment, publicity, artistic and musical material and matters pertaining to my professional activities and career in the entertainment music & recording.

(b) To advise and counsel me with respect to the adoption of the proper format for presentation of my talents and in the determination of proper style, mood and setting in keeping with my talents and best interests.

(c) To advise and counsel me with regard to general practices in the entertainment, music, recordings and with respect to compensation and terms of some simple contracts related thereto.

3. COMPENSATION:

Since the nature and extent of the success or failure of my career cannot be predetermined, it is my desire that your compensation be determined in such manner as will permit you too accept the risk of failure and likewise to benefit from the extent of my success. As compensation for your services, as hereinabove described, I agree to pay you, as and when received by you on my behalf the following compensation:

(a) A sum equal to the client contract I chose. I agree to pay you monthly [ ] contract length term [ ]

(b) You shall receive the foregoing compensation whether or not any employment, engagement, contract, agreement or other income producing activity shall have been procured by me as a result of your advice, consultation.

(e) You may, at your sole discretion, when packaging and selling a television show, seek to obtain an executive producer credit and fee, as well as backend and merchandising participation in the show. If you are able to obtain such a credit and fee, it will replace the 20% commission for that transaction. Your back end proceeds will be defined in the same manner as mine.

(f) All Income pursuant to this Agreement will be paid by paypal, online or cash payable to Hoodrich Entertainment and delivered directly to Aneesah Bray by the maker of the payment.

4. AGENCY REPRESENTATION:

(a) ALTHOUGH YOU SHALL ADVISE ME CONCERNING PROSPECTIVE EMPLOYMENT OR ENGAGEMENTS, IT IS CLEARLY UNDERSTOOD THAT YOU ARE NOT AN EMPLOYMENT AGENCY OR A THEATRICAL AGENT, THAT YOU HAVE NOT OFFERED OR ATTEMPTED OR PROMISED TO OBTAIN, SEEK OR PROCURE EMPLOYMENT OR ENGAGEMENTS FOR ME, AND THAT YOU ARE NOT OBLIGATED, AUTHORIZED, LICENSED OR EXPECTED TO DO SO.

(b) I hereby advise you that my licensed talent agency at the present time is \_\_\_\_\_ . INDEPENDENT ACTIVITIES: You may have and maintain other interests of any kind, either of your own or in the activities or enterprises of others and you shall have the right to render your services to anyone else (including owners of productions of any kind in which services or other attributes are utilized) either in the capacity in which you are employed by me hereunder or otherwise.

6. EXCLUSIVITY: I agree not to employ during the term hereof any other person or entity to act for me in the capacity in which I have engaged you hereunder.

8. CONSULTATION: I shall refer to you verbal or written leads, communications or requests for the rendition of my services. I shall consult with you concerning engagements, performance, booking or contract offered to me and I shall also consult with you regarding engagements, performance, booking or contract that I accept.

8. **AUTHORITY:** You may, on my behalf, do the following: approve and permit any and all publicity and advertising; approve and permit the use of my name, photograph, likeness, voice, sound effects, caricature, literary, artistic and musical materials for purposes of advertising and publicity and in the promotion and advertising of any and all products and services. I shall refer to you verbal or written leads, communications or requests for the rendition of my services in the entertainment, amusement, music & recording fields.

9. Miscellaneous

- (a) I shall at all times defend, indemnify and hold you, and your respective agents, employees, representatives, affiliated entities, successors, heirs and designees or legatees, harmless from and against any and all claims, damages, liabilities, costs and expenses, including without limitation, reasonable legal expenses and attorneys' fees, arising out of any breach by me or any warranty, representation or agreement made by me.
